2.1 Information about the educational program

In the master's program (scientific, pedagogical and specialized areas) there are 2 educational trajectories: No. 1 "State legal management of the agro-industrial complex", No. 2 "Agrarian legal".

### 2.2 Information about students

Currently, 314 students are studying in the educational program 6B04201 (bachelor), of which 263 are in the state language and 51 are in Russian,

The educational program 7M04101-Jurisprudence (Master's degree) includes 7 Master's students. Over the past two years, we have seen a positive trend in the number of students studying in the EP Jurisprudence

### 2.3 Internal conditions for the development of EP

For the training of bachelors and masters, the department has modern teaching and laboratory rooms, technical teaching aids, visual and demonstration materials.

The department's lecture rooms are equipped with modern visual aids and computer programs that allow educational and scientific work to be carried out at the level required by curricula and programs. When conducting classes using computer technology, a computer class and a teaching and learning room are used. The classroom is equipped with the materials necessary for the educational process (educational, methodological and additional literature, visual and handout materials).

The sanitary condition of the auditorium and offices complies with the required regulatory documents. A passport has been drawn up for each audience, indicating the seats, the amount of equipment, and the occupied space.

For persons with disabilities, accessibility of traffic routes and duplication of ramps is ensured. Particular attention is paid to computer interactive technologies.

The provision of educational programs with educational and methodological complexes of disciplines is 100%. Acquisition of new educational and scientific literature in accordance with the EP.

The teaching staff of the department have personal computers and free access to the Internet. One of the tasks of the Department of Law is the development of a joint educational program with leading universities, the implementation of which is aimed at integration into the international science-based space through the academic exchange of teachers and students.

The implementation of academic mobility is carried out with such universities as: Kazakh Agrotechnical University named after. S. Seifullin (Astana), West Kazakhstan Agricultural and Technical University named after. Zhangir Khan (Uralsk), University of Salerno (Italy), University of Plovdiv (Bulgaria), Slovak Agricultural University (Slovakia), Financial University under the Government of the Russian Federation (RF), Northwestern University of Agriculture and Forestry of the People's Republic of China (PRC), Agricultural University (Poland).

Scientists from abroad will be involved in delivering lectures: the China-Russia Research Center for Agricultural Science and Technology Policy (PRC).

Mobilizing working practitioners to the educational process allows you to integrate theory with practice and helps graduates quickly adapt to the professional environment.

### 2.4 Characteristics of the surrounding society

The priority direction in the development of the educational program is student-centered learning, focused on the student's personality, revealing his individual abilities, forming the student into an active and interested future specialist in the educational process.

The basis of the educational environment is the social component, the image of KazNARU, mutual responsibility, moral and emotional climate; social support for students, extracurricular

activities (sports clubs, scientific communities, etc.). One of the key components is also the intellectual development environment: modern technologies of developmental education (interactive teaching methods), a system of electives (business games, excursions), a system of elective courses in various areas of educational programs for acquiring knowledge on a specific topic, a system of intellectual competitions at various levels (subject and interdisciplinary Olympiads, competitions, tournaments, intellectual marathons, games, etc.), a system of supporting gifted students.

All components of the structure of the educational environment are open, there is an opportunity to realize oneself, which leads to increased motivation for educational activities and improves communication skills.

In the process of developing educational programs on a modular basis, a structural and logical scheme was built for the formation of a vocational educational program for a specialty with the involvement of students and employers at all levels of the educational process.

Employers take a particularly active part in the practical preparation of students for their professional activities by organizing and conducting internships. Specifically, the following employers are actively involved in the development of the plan: General Director of Global Professional Development LLP B. Aitzhan A.K., National Law Academy represented by President Kuandykov B.Zh.

They represent the interests of specialists in the field of jurisprudence of the agro-industrial complex and express opinions on the structure and content of the EP in accordance with the development priorities of the agricultural sector of the Republic of Kazakhstan, make proposals for the inclusion of new disciplines in connection with the demands of the labor market for the qualifications of EP graduates.

## 2.5 Information about teaching staff implementing EP

The department employs Doctors of Law, Candidates of Science, Associate Professors, Doctor of PhD and senior teachers, the department's graduation rate is 62.5%, which tends to grow annually. Employees of the department have the opportunity to improve their qualifications in leading research centers of the Republic of Kazakhstan and beyond. The teaching staff publishes scientific articles not only in industry journals of the Republic of Kazakhstan, but also in journals with an impact factor included in the Web of Science and Scopus database.

The achievements of the educational program include the training of targeted specialists, scientific and pedagogical personnel and the conduct of scientific research on the basis of concluded agreements with the specialized Research Institute "Law" of the Turan University institution and government agencies.

# 3 CHARACTERISTICS OF THE PROBLEMS TO SOLVING THE EP DEVELOPMENT PLAN

Today the department has the following problems:

lack of availability of electronic textbooks and training programs;

- low provision of educational and methodological literature in a foreign language;

- - low motivation of the department's teaching staff to publish scientific articles in journals with a non-zero impact factor;

poor provision of scientific laboratories with new generation equipment and instruments;
 incomplete equipment of classrooms with interactive whiteboards.

## 4 MAIN GOALS AND OBJECTIVES OF THE EP DEVELOPMENT PLAN

The main goal of the educational program development plan is to improve the conditions for obtaining a full-fledged, high-quality professional education in accordance with the vision, mission and strategy of the university, aimed at creating competitive, highly qualified personnel in the field of jurisprudence, possessing modern systemic knowledge and the necessary competencies for active participation in the industrial and innovative development of the Republic of Kazakhstan, in demand in the field of jurisprudence, both in Kazakhstan and in the global scientific and educational space, as well as for the development of socially oriented, highly cultured and competent person.

## 6 MECHANISM FOR IMPLEMENTATION OF THE EP DEVELOPMENT PLAN

Carry out career guidance work on a regular basis among school and college graduates in order to attract applicants on a paid-contractual basis through cooperation with the administration of educational institutions at the district and regional levels, providing consulting assistance to applicants from rural schools in preparation for the UNT, choice of specialty, organization of Olympiads in UNT disciplines in rural schools, holding an "Open Day" at the faculty. Conduct negotiations with regional akims on the allocation of targeted grants for EP training.

Annually update the content of educational programs of the specialty based on a generalization of modern domestic and international training experience in this area, the requirements of employers and the demands of the labor market. Improving the QED taking into account the proposals of interested parties, and primarily taking into account the opinions of employers.

To intensify scientific work at the department by involving teaching staff studying in proactive, state-

funded research and publishing scientific results in journals with a high impact factor.

Qualitative renewal of teaching staff is carried out on the basis of continuity by attracting talented young people to teaching and scientific activities, as well as training our own personnel through PhD doctoral studies.

Development of international academic mobility of students and teachers by building their individual learning path and choosing educational programs from various universities around the world, including internships for students and teachers in leading foreign universities.

Organization of professional practices on the basis of leading enterprises of the Republic of Kazakhstan. Ensuring a high proportion of employed graduates of the educational program by organizing and holding the annual "Graduate Fair" with the involvement of employers from all areas of various forms of economic entities in the regions of the Republic of Kazakhstan.

are developing catalogs of elective disciplines with the direct participation of employers and students.

The department's teaching staff will actively implement innovative technologies in education and science through the implementation of academic mobility with domestic and foreign partner universities and research institutes. Ensuring a high proportion of employed graduates of the educational program by organizing and conducting the annual "Career Week", "Job Fair", industrial practice and internship with the involvement of employers.

Teaching staff and students must participate in international educational programs, participate in competitions for grants for travel to participate in scientific conferences (seminars, congresses, conventions) and scientific internships.
